About the Simplified Chinese Glossary

Before using this glossary, please take a moment to understand its construction and limitations.

This glossary was compiled from a list of English terms from different Wells Fargo business lines. During the development process, more than 12 participants reviewed and edited the words and definitions, followed by a secondary review by an outside consulting team, and a final review by an external in-language legal counsel. With so many eyes looking at the same terms, you may be tempted to think this Glossary is perfect - it isn't. It is, however, a very good list based on a broad consensus about the terminology used in our businesses.

Most English terms have a single Chinese equivalent. Many terms have options based on context. Be sure to read any notes associated with a term. Chinese can be written in two major formats, Traditional and Simplified. Traditional Chinese is used outside Mainland China, such as Taiwan and Hong Kong, and in overseas Chinese communities in the United States. Simplified Chinese is mostly used in Mainland China. Traditional Chinese is generally used in written communications in the United States, to avoid alienating readers from Taiwan and Hong Kong. Chinese readers from Mainland China generally accept the usage of Traditional Chinese as a standard practice in the overseas Chinese communities.

Caution: This glossary is not a substitute for Simplified Chinese fluency or translation skills. One can never have a whole real right in relation to someone else's property.
